Artists will be notified by email (if provided) of acceptance by April 1, 2010 and all booth fees will be deposited upon notification. Booth fees for artists not accepted will be returned with slides in self-addressed envelope. Images of accepted artists may be used for publicity purposes. Alternates will be chosen during the jury process and will be notified by telephone in the event of a cancellation. Acceptance by the selection committee signifies commitment to participate by the artist. NO Booth fee refunds will be made after April 16, 2010. Cancellations after April 16th must be done in writing or by email if provided. 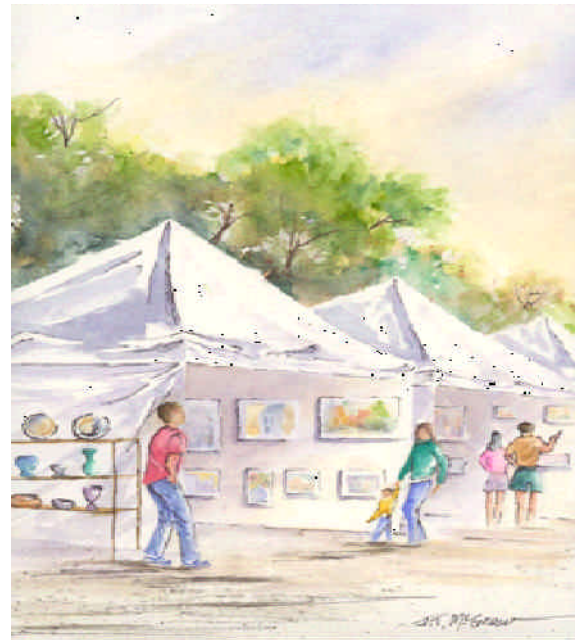

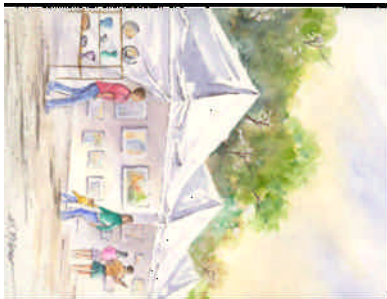

Please include a separate check for \$50 in addition to the \$250 check if you are requesting a corner booth space. Corners are assigned by date application is received.

Eligible Media

Ceramics, drawing/pastels, fiber, paintings, oil, ink drawings, glass, wood, jewelry, metalwork, photography, sculpture and Giclee printings are the acceptable mediums.

All work submitted and exhibited must be the "original work" of the Artist and produced only by the exhibiting Artist. Signed, limited edition reproductions shall be allowed, but no photo copies.

Reproductions must occupy less than one third of the total display area. No items will be accepted which are deemed "inappropriate" by the show committee.

The Artist whose work has been accepted must be present for the duration of the show!

Awards

Awards will be given to "Best" of both 2-D and 3-D categories. \$2,500 in prize money and \$25,000 in Purchase Patron Program for 2010.

Each Artist will be screened during the show and if the work displayed is not representative of the slides submitted, the Artist may be asked to leave the show.

NO ARTIST PETS ALLOWED, NO GAS OR DIESEL GENERATORS AND NO MUSIC ALLOWED IN ARTIST'S BOOTHS!

Security

While the Town Art Show will provide on-premise security through the night, each Artist exhibits at his or her own risk. Neither the show Committee nor Town Center Plaza is responsible for theft, loss or damage of or to an Artist's work.

Artist Donations

Each year we ask artists to donate for a drawing for the Parkinson Foundation.

Jury Procedure

1. **Send four (4) 35mm slides or digital images per category**, each labeled with artists name, media, size and top clearly indicated. A slide or digital image of your booth setup is also required. Slides must be inserted into a vinyl slide strip holder (5 slides total).
2. **Slides, checks and signed applications must** be accompanied by a #10 legal sized, self addressed envelope with correct postage affixed.
3. **A nonrefundable jury fee** of \$30 per category. (This is a donation to the Parkinson Foundation)
4. **A \$250 separate check or money order** for booth fee. (If requesting a corner, another **separate \$50 check** is required.) If request cannot be honored, it will be returned. No slides will be returned unless the application is accompanied by a self-addressed envelope with adequate postage.
5. **A physical signed application and check(s)) must be received for each artist.**
